Financials:

Membership Report:

Steve Fiorello reported that they were a little late in getting the 2013 membership renewal forms out to members but that this will be done very soon. The deadline for getting membership forms in is February 28, 2013.

Education Update:

Michelle Price announced that today's meeting was approved for PHR/SPHR credit and that certificates were on the registration table. She noted that the spring testing is May 1-June 30 with the application period will be opened on January 22, 2012 and that applications are being accepted through March 22, 2013

Michelle reported that you now can obtain recertification credits by reading books approved by the SHRM book club. Also, there are two additional certifications (Global) now available.

Michelle noted that 9 students have been match up with HR professionals through the mentoring program.

Legislative Update:

Kendra Mosman reported that for the first time, you can receive HRCI recertification credit for reading selected HR books within the SHRM Book Club. Use this link (<u>http://shrmstore.shrm.org/hr-certification-institute/shrm-book-club.html</u>) to navigate to the selected books. After reading the approved book, simply complete the online test and score 70% or higher. You will then receive a program ID that entitles you to 2.5 credit hours. You may earn up to 20 total credits in a three-year recertification cycle!

Foundation Update:

Kevin Stow called members attention to the flier on each of tables that gives more information about the SHRM Foundation and sample articles and free resources that the Foundation provides.
