Leyla's pro bono work includes providing counsel and legal assistance to immigrant survivors of domestic violence and other violent crimes in obtaining legal immigration status through the Mdivani Corporate Immigration Law Firm's Pro Bono Program. As Spanish is her first language, Leyla's pro bono work is focused primarily in serving women and children victims from the Hispanic community. In addition to practicing business immigration, Leyla is a certified Diversity & Inclusion/Unconscious Bias speaker and trainer. She recently completed her Diversity and Inclusion certification through Cornell University.
